THE SEPIK VILLAGES UNITED THEIR VOICE TO BAN THE MINE

All the villages along the Sepik River, including Iniok on Frieda River, are united in one voice and one accord: Their position has always been clear: They want the Frieda Mine Banned.

2: THE CAMPAIGN RECEIVED WIDE SUPPORT ACROSS PNG

The people of greater Sepik region and Papua New Guinea support the campaign and Project Sepik. Their voices can be heard everywhere, more amplified with aggression on social media. THE EAST SEPIK GOVERNMENT VOTED TO REJECT THE EIS

More than 20 members of the East Sepik Provincial Government Assembly unanimously voted to Reject the Proposed Mine Tailings Dam. They also voted to reject the Environmental Impact Statement (EIS) called the Sepik Development Plan in the form in which it was submitted. 100 % rejected the proposal. That is a united stand.

THE WEST SEPIK GOVERNMENT VOTED TO REJECT THE EIS

West Sepik Provincial Government Assembly voted to reject the EIS called the Sepik Development Plan in the form in which it was submitted.

5 ALLAN BIRD THREATENED CEPA WITH LEGAL ACTION

The East Sepik Province Governor, Allan Bird, has been the greatest revelation in the campaign. His leadership in the Office of the Governor and the East Sepik Provincial Assembly is commendable. He threatened the Conservation Environment Protection Agency (CEPA) to take legal action if an Environmental Permit was issued based on the defective and rejected EIS.

6 UN SPECIAL RAPPORTEURS SUPPORTED THE CAMPAIGN

Ten United Nations (UN) Special Rapporteurs heard the people's concerns and fears, the Supreme Sukundimi and the campaign. The UN Special Rapporteurs each wrote a letter to the following:

7 THE MOVEMENT TO SAVE THE SEPIK GREW EXPONENTIALLY

Project Sepik started as an obscure group of loosely connected Sepiks who were fearful and angered by the idea that the resistance against the Frieda Mine along the Sepik river was maligned, dimmed and suppressed. They met under trees and planned on how to build a campaign. Project Sepik was branded as NGOs misinforming people on the Sepik river, Project Sepik's representative concerns and arguments put out on the curb and margins of conversations. Project Sepik's persistence, calculated aggression and respectful engagement with its supporters ensured the voice of the Sepik River is heard worldwide. By 2020, the Supreme Sukundimi, the Sepik River's spirit, through its powers stood up with the Sepik River, all its lifeforms and with Project Sepik. Today, Project Sepik is surrounded by champions of Rivers, Environment, Climate, Sustainable Development and Justice movements. Project Sepik voice is now a respected voice in the ongoing Frieda Mine Narrative.
